Statement

Dear Presidents,

I am Diana Barragan from BPW Ecuador and I'm an Attorney at Law.

I'm aware of my challenges as a woman of the 21st Century; gender inequality has always been the common denominator in women's life. Even if for us Western women our needs, yet to be met, are secondary needs, social media and international press remind us every day how some of our sisters close to us still suffer from discrimination and abuse in all the areas of their lives and at all levels of society. I could not ignore it.

When I was first invited to join BPW Geneva Club in Switzerland in 1991, I realized that I had found a space from which I could contribute to change. It was a very active and committed club where I learnt to channel my efforts with all means BPW International offers its members. BPW Members have that in common, we are concerned about the lack of gender equity; our sisters' suffering is also ours and we are moved by the desire to influence change. Although this does not differentiate us from many other women activists, what makes us different is we have learnt how to channel and structure our efforts. We do it by organizing and supporting each other. We share similar goals and objectives, voluntarily submit ourselves to an institutional structure with the indispensable tools to achieve those goals; we have partnered with international organizations to make our work more effective. In exchange for all these benefits, we provide with our skills and good will that are the seeds from which BPW International has grown.

Once in Ecuador, I learnt what it means to lead- to better serve and convey the message. However, it is not enough to reach a decision-making position, it is essential to know how to leave it behind and return to a position from which we follow somebody else's leadership just as good as or even better than ours. I was twice President of BPW Quito and once of BPW Ecuador. I have also held international functions. It has not been an easy task, but I have tried to fulfill it with responsibility, dedication and commitment.

Today I thank my Federation BPW Ecuador for my nomination and the Presidents of Latin America for their confidence in selecting me during the Regional Conference as their next Coordinator. If elected by the General Assembly, I will serve with creativity and individuality, yet always respecting the rules and structure of BPW International.

I know BPW International needs its membership, therefore I will strive to preserve and grow it from the Region. I also know that together we can be more effective and I will promote union and friendship among Latin America members and with those around the world. Another important challenge for an organization such as BPW International, is communication. I will see to it that it is fluid for a good governance and member's benefit.
